## RELEASE FOR IMAGES AND AUDIO/VIDEO PRODUCTIONS

AUTHORIZATION FOR FILMING, DISSEMINATION AND USE OF INTERVIEWS/REPRODUCTIONS/PRODUCTIONS/PHOTOS AND/OR OTHER ACTIVITIES UNDERTAKEN during the Movie & Media Labs, event organized by the Department of Education and Learning/University of Teacher Education (DFA/ASP) of the University of Applied Sciences and Arts of Southern Switzerland (SUPSI)

The undersigned<sup>1</sup>, as the legal representative/person exercising parental authority over the enrolled minor, authorizes SUPSI, through its collaborators, students, employees or freelancers and partners (specifically the Locarno Film Festival and its employees, collaborators and partners within the framework of the event) authorized to do so, to carry out the following activities:

- perform or cause to be performed photographic and/or video and/or audio shooting of the images of the person concerned<sup>2</sup> enrolled in the activities of Movie & Media Labs;
- use and/or modify in any form or manner, for the purposes indicated in this release, for its own institutional purposes and in particular for educational purposes and/or to publicly promote the image of the institution without limitations of space, time and without indemnity, any audio and video recordings, interviews and photos that portray (even in close-up) the minor and/or his/her contributions that will be made during the activities planned within the Movie & Media Labs (hereinafter referred to as "activities"), in particular by way of example but not limited to: utilize, publish, screen, exhibit and present in public, reproduce and disseminate (including live, through the usual SUPSI communication channels or as deemed appropriate);
- use, at its own discretion, on printed materials produced by the school, for events run by SUPSI or third persons or entities authorized by it, on social networks and websites of SUPSI or third persons or entities authorized by it, and on any other educational and/or promotional media (including advertising brochures, media advertising forms and others), all of the above activities, as a whole or separately, in whole or only in part, using all media means, in any form, without any restrictions and without limits;
- transfer and store said images or said material in the SUPSI appointed archives for 10 years from the issuance of the authorization or, in any case, until any revocation of this authorization, without prejudice to SUPSI's obligations and duties under the law.

The undersigned declares as of now:

- that nothing will be claimed in connection with the subject matter hereof,

- to waive any mention on the occasion of such use of the image,
- to exonerate SUPSI from any claim for financial compensation and from any form of liability however connected with and/or arising from the misuse in the web of the images by third parties.
- to assign to SUPSI all rights (copyright and related rights, image rights, property rights) arising from the services/activities issued and/or delivered and/or sent to SUPSI or filmed by SUPSI.

The undersigned attests and guarantees that no agreements with third parties or third-party rights oppose the uses set forth in this statement.

Any dispute arising from the agreement confirmed by this declaration shall be governed by Swiss law. Any dispute that cannot be settled amicably between the parties shall be submitted to the jurisdiction of the Magistrate's Court of Lugano.

Aware of the fact that a considerable number of children are taking part in the event, the undersigned recognizes the objective impossibility of SUPSI to duly inform the person concerned whenever the image in the broad sense, or a part of it, will be disseminated or caused to be disseminated, using broadcast media.
